ImmuneOnco Biopharmaceuticals (Shanghai) Inc. (the "Company") has received the filing notice from the China Securities Regulatory Commission and the approval from The Stock Exchange of Hong Kong Limited (the "Stock Exchange") of the conversion of 120,463,260 unlisted shares of the Company (the "Unlisted Shares") into H shares of the Company (the "H Shares") and their listing on the Stock Exchange, as disclosed in the announcements of the Company dated 29 May 2024 and 3 September 2024 respectively.
